C. Amendment Request: *Spectrum Academy*

Spectrum Academy is requesting an amendment to the Spectrum Academy Charter Agreement to make changes to the goals (attachment A), changes to the Bylaws (attachment B), remove original application sections (attachment C), and changes to the school mission (attachment D). The Authorizing Committee has reviewed the amendment request has no concerns. This amendment is recommended for approval.

D. Amendment to Bylaws: *Summit Academy Schools*

Summit Academy Schools is requesting an amendment to the Summit Academy Charter Agreement to make changes to the Bylaws to Article II, Section 5 for the board to meet at a minimum of six times per year. Article II, Section 1 and 3 were amended to clarify the role of the Board and relationship with the Director, and program accounting was added to the requested sections.
