

## ARTICULATION AGREEMENT

THIS Agreement is entered to between John Hancock Charter School and Utah Academy of Sciences on 19 day of September 2019 and was approved by the John Hancock Charter School's Board of Directors on 18 day of June 2019 and the State Charter School Board on \_\_\_\_ day of \_\_\_\_\_ 2019.

1. **PURPOSE.** This Agreement creates the structure for John Hancock Charter School students to articulate into Utah Academy of Sciences's student body. Both school serve many of the same population areas, have like-minded families, similarly trained teachers, high expectations, rigorous academics, similar curricular goals, instructional methods and similar behavior models.

2. **EFFECTIVE DATE AND TERM.** This Agreement becomes effective immediately after it has been approved by both schools' Governing Boards and the Utah State Charter School Board. This Agreement will apply to the student attending in the 2021-2022 school year and will continue until terminated. Termination can be made by any party at anytime with thirty days written notice before the UCAS lottery held in February of each year.

3. **COMPLIANCE WITH LAW.** The parties comply with the requirements of state and federal law and regulations relating to this Agreement.

4. **COMPLIANCE WITH UTAH VALLEY UNIVERSITY.** All students must comply with the requirements of Utah Valley University (UVU), concurrent enrollment, registration requirements, etc. before the student can fully articulate to the Utah County Academy of Sciences.

5. **ARTICULATION.** During the enrollment period, first priority may be given to siblings and founders' children of Utah Academy of Sciences and others accorded preferences pursuant to Utah Code as adopted by Utah Academy of Sciences in its charter, bylaws. Second priority will be given to John Hancock Charter School students prior to admitting students from the lottery up to 25 students per year.


6. **COOPERATION.** The parties to this Agreement shall cooperate with one another in good faith to fulfill the terms of this Agreement.

7. **ENTIRE AGREEMENT.** This Agreement represents the entire understanding and agreement of the parties. Reasonable administrative timelines and procedures will be mutually decided by directors of both parties.

8. **COUNTERPARTS.** This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.


